2. The Tenderers may submit tenders for any or all the items listed above. Tenderers are advised to note the qualification criteria specified in Clause 15.0 to qualify for award of the tender.

3. Tender documents may be purchased from the office of Managing Director, Kerala Livestock Development Board (KLDB), Gokulam, Pattom P.O, Thiruvananthapuram – 695 004, Kerala State, India, up to 3 PM on 29/01/2010, during office hours, by paying non refundable fee as given below in the form of Cash / Demand Draft/Pay Order on any Nationalized/Scheduled Bank payable at Thiruvananthapuram in favour of Managing Director, KLD Board. Interested tenderers may obtain further information at the same address. Tender documents requested by mail will be dispatched by courier/speed post on payment of an extra amount of INR 500 / USD 50. The KLDB will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same. **TERMS AND CONDITIONS FOR IMPORTATION OF
PROGENY TESTED BOVINE FROZEN SEMEN (In French Mini Straws),
AND IN VIVO BOVINE FROZEN EMBRYOS**

1.0 PREFACE

The Kerala Livestock Development Board, Gokulam, Pattom P.O, Thiruvananthapuram – 695 004, Kerala State, India (hereinafter referred to as the ‘BUYER’ which expression shall unless repugnant to the subject of context mean and include its successor-in-office, successor-in- interest and successor - in title and permissible assigns) invites sealed tenders (one Technical Tender marked as “A” giving details of the expertise they are having in export of Progeny Tested Bovine Frozen Semen and in vivo Bovine Frozen Embryos along with profile of the firm or company and another Commercial Tender marked as “B” furnishing details of price offered etc.) from bonafide breeders, or other accredited authorized representatives for supply of Progeny Tested Bovine Frozen Semen and in vivo Bovine Frozen Embryos for breeding purpose mentioned in the notification strictly in adherence to the detailed specification given in the schedule of tender.

- 1.1 The manufacturer should submit all the tenders directly or through their authorized distributor/ representative in India, provided the manufacturer accepts responsibility for any lapse on the part of such distributor/ representative. In cases where the tenders are submitted through authorized distributor/ representative, the authorization certificate from the manufacturers to this effect must be enclosed.
- 1.2 The Kerala Livestock Development Board, Thiruvananthapuram reserves the right to accept or reject any tender, and to annul the tendering process and reject all tenders at any time prior to contract award, without assigning any reason. The purchaser will not be under any obligation to inform the affected Bidder or Bidders of the grounds for the Purchaser’s action.

2.0 TENDER PROCEDURE

2.1 The tenders shall be sent by Registered Post with acknowledgement due / courier so as to reach the Managing Director, Kerala Livestock Development Board, Gokulam, Pattom P.O, Thiruvananthapuram – 695 004, Kerala State, India, not later than 11 AM on 03/02/2010. If the Tenderers or their agents in India do not propose to send the tenders by Registered Post and if they wish to hand over the tenders personally they may do so by personally handing over the tender to the Managing Director, Kerala Livestock Development Board, “Gokulam”, Pattom P.O, Thiruvananthapuram – 695 004, Kerala State, India against an acknowledgement not later than the time and date specified above.

2.2 Procedure for Submission of Bids

A TWO-COVER system will be followed for this tender

A. Technical Bid (2 copies) in one cover

B. Financial Bid (2 copies) in one cover

Each copy of the Technical Bid (Original and Duplicate and identified accordingly) should be put in separate covers and sealed. The cover should be super scribed as “TECHNICAL BID”. Each copy should also be marked as “ORIGINAL” and “DUPLICATE” as the case may be. Both the copies should then be put in a single cover and sealed. This sealed

cover should be super scribed as “TECHNICAL BID”. The tender marked ‘ORIGINAL’ shall alone be considered for the purpose of evaluation. PLEASE NOTE THAT PRICES SHOULD NOT BE INDICATED IN THE TECHNICAL BID. TENDERS SUBMITTED WITHOUT FOLLOWING THE TWO BID SYSTEM PROCEDURE WILL BE SUMMARILY REJECTED.

2.3 FINANCIAL BIDS SHOULD BE SUBMITTED SEPARATELY FOR EACH OF THE ITEMS INDICATED IN THE SCHEDULE (As per Annexure I) IN SEPARATE SEALED COVERS IN DUPLICATE. Each copy of the Financial Bid should be put in a separate sealed cover super scribing the wordings, “FINANCIAL BID”. Each copy should also be marked as “ORIGINAL” and “DUPLICATE”. Both the copies should be put in a single sealed cover super scribing the wordings “FINANCIAL BID” Specifying the item quoted for. The bid marked ‘ORIGINAL’ shall alone be considered for the purpose of evaluation. However if the amount of any item put to tender is at variance between the Original and Duplicate, the lowest will be considered for evaluation.

2.4 Both the Technical and Financial bid cover prepared as above are to be kept in a single sealed cover super scribed with Tender reference and the item quoted for. The outer cover should also indicate clearly the name and address of the bidder and bear the address of the Kerala Livestock Development Board Ltd. Only one complete tender (in Duplicate) should be kept in a cover. In case more than one tender is kept in the cover all tenders so kept shall be liable to be ignored.

2.5 No responsibility shall arise against KLD Board for the premature opening of the tender, which is not properly addressed and identified.

2.6 No telegraphic/telephonic/telex/.fax/.e-mail tender will be considered.

2.7 **EARNEST MONEY DEPOSIT**

2.7.1 . All the Tenderers shall be required to pay Earnest Money Deposit (EMD), in Indian Rupees or US Dollars as specified below, in the form of Cross Demand Draft / Bankers Cheque/Pay order drawn in favour of the Managing Director, Kerala Livestock Development Board, Gokulam, Pattom P.O, Thiruvananthapuram – 695 004, Kerala State payable at THIRUVANANTHAPURAM or a Bond/Guarantee given by a Banker of the Tenderer for an equal amount in the prescribed form given at Annexure-III. In this regard, it may please be noted that the tenders accompanied by any other form instead of Demand Draft / Bank Guarantee towards Earnest Money will not be considered. The Demand Draft/Banker’s Cheque/Bank Guarantee should be put in the cover containing the technical bid.

- 2.7.2 Any tender which is not accompanied by EMD shall be summarily rejected. EMD of unsuccessful tenders will be returned within 90 clear days from the date of opening of the tender. The EMD of the successful tenderer will be released on submission of a performance guarantee.
- 2.7.3 No interest shall be paid for the Earnest Money for the period during which it (the earnest money) lies in deposit with the Kerala Livestock Development Board. The validity of the EMD should be for 6 (Six) calendar months beyond the validity of the tender.
- 2.7.4 The Tenderers should state in their tenders, the complete address to which the orders, notices and further correspondence pertaining to the Tender and agreements are to be sent. Any change of address thereafter must be notified to the Managing Director, Kerala Livestock Development Board, Gokulam, Pattom P.O, Thiruvananthapuram – 695 004, Kerala State, India, and subsequent correspondence shall be sent at the new notified address.

2.8 Opening of Bids and Award of Contract

2.8.1 Opening of Bids by Purchaser

The technical bids will be opened on 03/02/2010, at 3.00 PM (local time). The bids will be opened in the presence of Bidders/Representatives who choose to attend on the date and time as mentioned. The Bidders/ representatives who are present shall sign a register evidencing their attendance. The Bidders/ representatives shall furnish letter of authority from their principals to attend the bid opening.

- 2.8.2 Financial bids of Bidders whose bids are found technically suitable, only will be opened. The Financial bids of the short listed bidders will be opened at the Office of the Managing Director, Kerala Livestock Development Board Ltd as the case may be in the presence of their authorized representatives, if any. (the date of opening of Financial bids will be communicated to the technically successful bidders). The decision of the sub committee on technical suitability shall be final and shall not be open for discussion.

2.8.3 Award of Contract

Prior to the expiry of the period of validity, the Purchaser will notify the finally selected Bidder (s) in writing by registered letter or fax, to be confirmed in writing by registered letter, that its bid has been accepted. If a need for extension of the bid validity period arises, it should be extended by mutual agreement. The notification of award will constitute the formation of the Contract.

2.8.4 Negligence on the part of the Tenderers in preparing the tender confers no right to withdraw the tender, after it has been posted/handed over to the Kerala Livestock Development Board.

2.9 The specifications, conditions and schedules of the tender will constitute an integral part thereof.

2.10 Corrections in the tender if any should be noted over and initialed at as many places as the corrections occur. On each page of the tender the tenderer should indicate the number of corrections/over writings made both in figure and also in words.

2.11 The tender shall be free from any qualifications. The prices quoted by the tenderers shall be inclusive of all rates, taxes, duties etc.

2.12 In case of mathematical errors in computation found in the tenders and in the case of substantial non conformity with the specifications or if it contain any inadmissible reservations, seen or otherwise, in contravention of the spirit and letter of the tender documents, such tenders shall be summarily rejected.

2.12.1 The supplier shall supply progeny tested proven frozen semen and in vivo bovine embryos only in accordance with the specifications stipulated.

3.0 **SPECIFICATIONS:**

3.1. **PROGENY TESTED BOVINE FROZEN SEMEN (IN 0.25ml MINI FRENCH STRAWS)**

3.1.1. Semen should be from progeny tested proven bulls with + sire indices (with reliability > 85%) based on progeny testing on at least 15 different cattle herds.

3.1.2. 305 day lactation yield of the dam of the bull and the average lactation yield of the daughters of the bull should be more than

- i. 10000 Kgs for Holstein Friesian
- ii. 6500 Kgs for Jersey

Signature of the tenderer

3.1.3 Predicted transmitting ability for milk:

- i. 800 Kgs for Holstein Friesian
- ii. 500 Kgs for Jersey

3.1.4. Fat percentage:

- i. Minimum of 4% for Holstein Friesian
- ii. Minimum of 5% for Jersey

3.1.5. Predicted transmitting ability for fat should be + for both Holstein Friesian and Jersey

3.1.6. Protein percentage: Minimum of 3.2% for both Holstein Friesian and Jersey

3.1.7. Predicted transmitting ability for protein should be + for both Holstein Friesian and Jersey

3.1.8. Post thaw Motility should be 50% and above

3.1.9. Post thaw Motility should be 25-30% after incubation for 2 hours at 37* C.

3.1.10 The requirement of Frozen Semen is as indicated below:

- Holstein Friesian –12000 doses.
- Jersey – 8000 doses.

From a minimum of -20 different bulls.

3.2 IN VIVO BOVINE EMBRYOS

3.2.1. Dams should be daughters of progeny tested proven bulls with dam's lactation yield and daughters average yield of 10,000 Kgs and above for Holstein Friesian with minimum 4% Fat and 6,500 Kgs and above for Jersey with minimum 5% Fat

Predicted transmitting ability of the dam's sire for milk: 800 kgs for Holstein Friesian and 500 kgs for Jersey

Fat percentage: Minimum of 4% for Holstein Friesian and minimum of 5% for Jersey. Predicted transmitting ability of the dam's sire for fat should be + for both Holstein Friesian and Jersey

Protein Percentage: Minimum of 3.2% for both Holstein Friesian and Jersey. Predicted transmitting ability of the dam's sire for protein should be + for both Holstein Friesian and Jersey

Signature of the tenderer

- 3.2.2 The sires should be progeny tested and proven with positive sire indices (with reliability of > 85%) based on based on progeny testing on at least 15 different cattle herds

305 day lactation yield of the dam of the sire and the average lactation yield of the daughters of the sire should be more than 10000 Kgs for Holstein Friesian and 6500 Kgs for Jersey.

Predicted transmitting ability for milk: Should be 800 Kgs for Holstein Friesian and 500 Kgs for Jersey

Fat percentage: Minimum of 4% for Holstein Friesian and minimum of 5% for Jersey. Predicted transmitting ability for fat should be + for both Holstein Friesian and Jersey

Protein Percentage: Minimum of 3.2% for both Holstein Friesian and Jersey. Predicted transmitting ability for protein should be + for both Holstein Friesian and Jersey

- 3.2.3 Embryos should be of ‘ A +’ grade.

- 3.2.4 The thawing protocol is to be supplied along with the embryos.

- 3.2.5. A. The requirement of embryos is as follows:
- Holstein Friesian – 300 Numbers
 - Jersey – 200 Numbers

3.3 Supporting technical documents such as Sire Directory/ Catalogues etc., should be enclosed along with the technical bid, duly certified by competent authority in proof of the genetic merit of the genetic material being offered.

4.0 VETERINARY HEALTH CERTIFICATE:

- 4.1. PROGENY TESTED BOVINE FROZEN SEMEN – AS PER ANNEXURE IV

- 4.2. FOR IN VIVO BOVINE EMBRYO – AS PER ANNEXURE V

5.0 PRICES FOR PROGENY TESTED FROZEN SEMEN:

- 5.1 The price quoted should be on CIF basis for progeny tested frozen semen.

- 5.2 While quoting, the tenderers are requested to mention the following:

1. The cost of progeny tested frozen semen including packing, forwarding charges up to port of shipment.

Signature of the tenderer

2. The Freight by air from port of shipment to the port of destination.
 3. Charges to cover all transit risk insurance etc., and
 4. Rates shall be quoted in figures as well as in words.
- 5.3 The prices thus quoted should be firm, free from all escalations and valid for a period of 180 (one hundred eighty) clear days from the closing date of the Tender.
- 5.5 The prices shall be quoted on Unit/ Item basis. Tenderers should clearly indicate the amount of discount that would be available on number of Units. The Tenderer should also indicate time, discount, if any available.

6.0 PRICES FOR IN VIVO BOVINE EMBRYO

- 6.1 The price quoted should be on CIF basis for in vivo bovine frozen embryos.
- 6.2 While quoting, the tenderers are requested to mention the following:
1. The cost of in vivo bovine frozen embryos including packing, forwarding charges up to port of shipment.
 2. The Freight by air from port of shipment to the port of destination.

Signature of the tenderer

3. Charges to cover all transit risk insurance etc., and
4. Rates shall be quoted in figures as well as in words.

6.3 The prices thus quoted should be firm, free from all escalations and valid for a period of 180 (one hundred eighty) clear days from the closing date of the Tender.

6.4 The prices shall be quoted on Unit/ Item basis. Tenderers should clearly indicate the amount of discount that would be available on number of Units. The Tenderer should also indicate time, discount, if any available.

7.0 **SHIPMENT - BOVINE FROZEN SEMEN AND EMBRYOS**

7.1 In the event of loss, the supplier will be responsible for replacement thereof free of cost.

8.0 **PLACE OF DESTINATION**

For purpose of tendering, the place of destination is or will be in all cases THIRUVANANTHAPURAM, KERALA STATE, INDIA. Hence rates to be quoted for delivery at Thiruvananthapuram.

9.0 **INSURANCE**

The supplier shall arrange Insurance coverage, according to the dispatch instructions issued by the buyer in the name of Kerala Livestock Development Board, Thiruvananthapuram, India and the supplier should cover all dispatches. However, to avoid complications that may arise at the time of settlement of the claims by the under writers for the transit losses, it is proposed that the insurance coverage shall be arranged by the supplier as under:

- a) The Insurance coverage has to be taken for all transit risks covering from the point of loading to the place of destination.
- b) Suppliers are required to take insurance with any national or international insurance company of repute;
- c) The cover provided by the Insurance shall be in such currency and in such amount so as to allow complete replacement for the consignment damaged.

Signature of the tenderer

- d) The supplier shall
 - i. initiate and pursue the claim till settlement.
 - ii. promptly make arrangements for replacement irrespective of settlements of claim by under-writers.

10.0 **GUARANTEE**

The supply of Progeny Tested frozen semen and In-vivo bovine frozen embryos should be in accordance with the specifications and to the entire satisfaction of the buyer and/or to the satisfaction of their technical officers. The tenderers who bid should ensure that the country of origin is free from Foot and Mouth disease.

11.0 **PERFORMANCE GUARANTEE**

- a) The successful tenderers shall have to furnish within 30 days from the date of purchase order, a bank guarantee/performance bond from any one of the Nationalized Banks or any one of the International Banks in the prescribed form given at Annexure-II for the due fulfillment of the contract for an amount in Indian Rupee equivalent to 25% (Twenty five percent) of the value of the contract valid for a period of 24 calendar months from the date of the bank guarantee and its validity period shall be extended by such period as may be required to cover the period of 24 calendar months from the date of receipt at the specified destination in India.
- b) In case the supplier fails to furnish the bank guarantee as required within the stipulated period, it shall be lawful for the buyer to forfeit the earnest money deposit lying with the buyer/their technical officer and cancel the contract or any part thereof. This is also without any prejudice to the other rights of the buyer under the contract.
- c) If the suppliers fail or neglect to observe or comply with or perform any of their contractual obligation it shall be lawful for the buyer to get reimbursed from the bankers of any amount not exceeding the amount of bank guarantee / performance bond as may be decided by the buyer. This is also without any prejudice to the other rights of the buyer under the contract.

12.0 **COMMERCIAL INFORMATION REQUIRED WITH THE TENDERS:**

12.1 **CURRENCY OF PAYMENT:**

The price of Progeny tested Bovine Frozen Semen and in-vivo bovine embryos shall be quoted by the Tenderers in either.

Signature of the tenderer

- a) In the Indian Rupee or
- b) In US Dollars.

12.2 To facilitate comparison of tenders, all prices will be converted into Indian Rupee. The rate of exchange to be used in such conversion shall be the selling rate fixed by the Reserve Bank of India and applicable to similar transactions on the day of opening of price bids. The same value will hold good for making payments to the successful bidder if such successful bidder happens to quote in USD.

12.3 The price of the Progeny tested frozen semen and in-vivo bovine embryos purchased will be paid in the Currency in which the price has been stated in the successful tender. Expenditure within India shall be paid in Indian Rupee.

12.4 **TERMS OF PAYMENT:**

Payment will be made through letter of credit as under:

70% (Seventy percent) of the shipment value will be paid upon receipt of evidence that complete shipment of the Progeny tested frozen semen and in-vivo bovine embryos has been effected. 15% (Fifteen percent) of the shipment value will be released after the receipt of the consignment to the satisfaction of the Buyer at destination. The balance 15% (Fifteen percent) of the value shall be paid after 4 calendar months from the date of receipt of the Progeny tested frozen semen and in-vivo bovine embryos at the specified destination in India.

However, the balance 15% may also be released, if so desired by the supplier, provided he furnishes a Bank Guarantee from a bank acceptable to the Kerala Livestock Development Board, Thiruvananthapuram for the 15% value of shipment in Indian Rupee valid for a period of 4 calendar months from the date of receipt of Breeding Bull Calves at the specified destination.

12.5 The documents required to be submitted by the suppliers to their bankers while negotiating the letter of credit established by the buyer are as under:

- i) Complete set of clean bills of lading of the shipment made out in the name of the bankers through which the letter of credit is opened in the account of Kerala Livestock Development Board, Thiruvananthapuram; showing that the frozen semen and embryos have been shipped and freight paid.
- ii) Copy of the valid insurance policy, evidence is also required that the said insurance company has been duly advised about the loading of frozen semen and embryos, expected time of arrival etc; according to the policy requirement.

Signature of the tenderer

- iii) Manually signed Commercial Invoices made in the name of the Kerala Livestock Development Board, Thiruvananthapuram
 - iv) Certificate of country of origin issued by the appropriate authority.
 - v) Combined weight certificate and packing details.
 - vi) Certificate from the buyer that the Bank Guarantee has been executed in accordance with the clause No. 11(a) of this Tender.
- 12.6 All charges of the foreign bank including those for the confirmation of the letter of credit, if required, shall be borne by the supplier.
- 13.0 **DELIVERY PERIOD**
- 13.1 The supplier should deliver the Progeny tested bovine frozen semen and in vivo bovine embryos within 3(three) calendar months from the date of placement of the purchase order. However, an early delivery stipulation may also be indicated.
- 13.2 In case of failure by suppliers in making deliveries, within the time specified, the Kerala Livestock Development Board, Thiruvananthapuram may procure the progeny tested bovine frozen semen and in vivo bovine embryos from other sources and hold supplier responsible for any losses occurred thereby. Further more, the Kerala Livestock Development Board, Thiruvananthapuram, reserves the right to terminate the services of such suppliers in such cases, without assigning any reason therefore.
- 14.0 **LIQUIDATED DAMAGES CLAIMS**
- In case the delivery of the progeny tested frozen semen and in-vivo bovine embryos is not made by the supplier before the stipulated delivery date, the supplier shall pay penalty at the rate of 1 ½ % (One and a half percent) of the value of the progeny tested frozen semen and in-vivo bovine embryos for every week of delay subject to a maximum of 15% of the net value of the accepted order which remains undelivered. If delivery has not been made, the buyer may at his discretion cancel the orders ten weeks after the expiry of the stipulated delivery period, unless the Kerala Livestock Development Board extends the validity in writing.
